On 18 August 2015, the Company entered into six separate Subscription Agreements with six Subscribers, pursuant to which the Subscribers have conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue an aggregate of 630,000,000 Subscription Shares at a price of HK\$0.10 per Subscription Share. As announced by the Company on 27 August 2015, the conditions precedent under each of the First Subscription Agreement and the Sixth Subscription Agreement have been fulfilled and the completion of the First Subscription and the Sixth Subscription took place on 27 August 2015 in accordance with the relevant Subscription Agreements. Accordingly, the Company have allotted and issued a total of 240,000,000 Subscription Shares to the First Subscriber and the Sixth Subscriber. For details, please refer to “item 10” “Other- Subscription of new shares” under “Other Movements in Issued Share Capital” in this monthly return and the Company’s announcements dated 18 August 2015 and 27 August 2015.

As at the date of this monthly return, completion of each of the Second Subscription, the Third Subscription, the Fourth Subscription and the Fifth Subscription has not yet taken place.
