On 18 August 2015, the Company entered into six separate Subscription Agreements with six Subscribers respectively, pursuant to which the Subscribers have conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue an aggregate of 630,000,000 Subscription Shares at a price of HK\$0.10 per Subscription Share.

As announced by the Company on 27 August 2015, the Company have allotted and issued a total of 240,000,000 Subscription Shares to the First Subscriber and the Sixth Subscriber as all conditions precedent under the relevant agreements have been fulfilled.

As announced by the Company on 14 September 2015, the Company have allotted and issued a total of 30,000,000 Subscription Shares to the Second Subscriber as all conditions precedent under the relevant agreement have been fulfilled. As announced by the Company on 30 September 2015, each of the Third Subscription Agreement, the Fourth Subscription Agreement and the Fifth Subscription Agreement were terminated as the conditions precedent under each of the agreements have not been fulfilled as of 30 September 2015.
