### **FURTHER EXTENSION OF THE LONG STOP DATE FOR COMPLETION OF CAPITAL INJECTION IN SHANXI ZHONGZE HENG YUAN BIOLOGICAL TECHNOLOGY COMPANY LIMITED\***

Reference is made to (i) the announcement of the Company dated 26 January 2015 in relation to the Capital Injection of RMB52 million by Beijing Kaiqiao to the Target Company pursuant to the Capital Injection Agreement dated 26 January 2015 entered into between Beijing Kaiqiao, Zhong Xiang and Hu Guosheng (the “**Announcement**”); (ii) the announcement of the Company dated 29 May 2015 in relation to the extension of the long stop date (“**Long Stop Date**”) for the completion of the Capital Injection to 31 July 2015; (iii) the announcement of the Company dated 31 July 2015 in relation to the further extension of the Long Stop Date to 30 September 2015; (iv) the announcement of the Company dated 30 September 2015 in relation to, among other matters, further extension of the Long Stop Date to 31 October 2015; and (v) the announcement of the Company dated 29 October 2015 in relation to the further extension of the Long Stop Date to 30 November 2015.

Capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement unless the context otherwise requires.

On 30 November 2015, Beijing Kaiqiao, Zhong Xiang and Hu Guosheng have agreed in writing to further extend the Long Stop Date to 31 December 2015 as additional time is required for fulfilment of the conditions precedent set out in the Capital Injection Agreement. The Board considers that such extension of the Long Stop Date is in the interest of the Company and the Shareholders as a whole. Save and except for the aforesaid extension of the Long Stop Date, all other terms and conditions of the Capital Injection Agreement shall remain unchanged and continue in full force and effect.
