(1) On 8 December 2015, the Company entered into two separate CB Subscription Agreements with two CB Subscribers respectively, pursuant to which the CB Subscribers have conditionally agreed to subscribe for and the Company has conditionally agreed to issue the Convertible Bonds in the aggregate principal amount of HK\$150,000,000 at the initial Conversion Price of HK\$0.115 per Conversion Share (subject to adjustment). Upon exercise in full of the conversion rights attaching to the Convertible Bonds, a total of 1,304,347,825 Conversion Shares will be allotted and issued. For details, please refer to the Company's announcement dated 8 December 2015 and circular dated 12 January 2016.

(2) On 8 December 2015, the Company entered into two separate Share Subscription Agreements with two Share Subscribers respectively, pursuant to which the Share Subscribers have conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue an aggregate of 1,740,000,000 Subscription Shares at the Subscription Price of HK\$0.115 per Subscription Share. For details, please refer to the Company's announcement dated 8 December 2015 and circular dated 12 January 2016.

The resolutions to approve the CB Subscription Agreements and the Share Subscription Agreements and the transactions contemplated thereunder (including the grant of the CB Specific Mandate and the Subscription Specific Mandate) were duly passed by the Shareholders at the Special General Meeting held on 28 January 2016.
